For example when Symbolic expressed concern that pornography might be accessed by the end users BPD "spidered" Italian and European Union Web sites to generate a list of over 100,000 Pornography sites. Any of the sites that did not exist in the BPD master URL Filter list were reviewed and added.

Integration of Content URL / Internet Filtering

The Challenge

Symbolic's use of the Websense OEM web filtering service was expiring and they needed a "plug and play" replacement for their "white labeled" Unified Threat Management (UTM) solution. The current solution provided service for thousands of customers representing over one million end user licenses. The replacement solution had to be accurate, have great coverage for web site filtering, and less expensive than Websense.

The BluePrint Data Solution

BluePrint Data's (BPD) URL Filter Database was installed in the UTM with filtering categories closely matching those of Websense. Integration was simple as software tools provided by BPD enabled a fast and accurate service replacement.

Symbolic was the first major Internet Filtering offering in the European Union by BPD. To
